



## What is changing with MA SkillsBuilder™: Clinical and MA SkillsBuilder™: Clinical Plus?

New enhancements will be added to the MA SkillsBuilder™: Clinical products as of June 26, 2024, and will impact any new courses started after this date.

You'll now have access to new features including:

- **Interactive Tour** to familiarize you with how to use the product, located under "Help"
- **Annotation Tools** including bookmarking, highlighting, and note taking capabilities
- **Progress completion bar** in the main menu will show how far a learner has progressed through a particular lesson
- **Centralized Video Library** provides a convenient review of all videos presented throughout a module

## Does this change impact the Sims quizzes or reporting capabilities?

No, this format change does not impact the Sims Quizzes or any reports.

## Does this update include any changes to the content within either of these products?

There are no changes to the content itself within the MA SkillsBuilder™: Clinical or MA SkillsBuilder™: Clinical Plus products. Only the format in which the content is presented will be updated.

## Why is the experience changing for the MA SkillsBuilder™: Clinical and MA SkillsBuilder™: Clinical Plus products?

This change will provide a cohesive learning experience across the MA SkillsBuilder™ Administrative and Clinical product line.

- **MA SkillsBuilder™: Clinical:** all modules will be updated to the new learning experience.
- **MA SkillsBuilder™: Clinical Plus:** The 13 foundations modules are currently in the new format. The remaining 12 skills modules will be updated to provide a cohesive learning experience between the skills and foundational modules.

## What do I need to do after June 26 when these enhanced products launch?

You don't have to do anything, but as an instructor/facilitator please be aware of the following:

- Any course that has already been started with an active learner in the course will have no impact. Learners will continue to use the existing products.
- NHA will automatically move any existing unused or unassigned inventory over to the new products on July 24, 2024.
- Instructors/facilitators can add new learners to an existing course (assuming inventory is available) up until inventory is automatically moved to the enhanced product.
- Beginning June 26, any new courses created should use the new enhanced versions of the product.
- Prior to July 24, if you are enrolling learners into a new course, please connect with your NHA representative first to ensure your inventory can be moved to the new experience.



**What will happen to my existing inventory?**

When the new version of the product becomes available on June 26, inventory will stay as is until July 23. On July 24, all unassigned or unused inventory will automatically be moved over to the new versions of the product. No action is needed on your part.

**What are the names of the current products and what are the names of the new enhanced products?**

**What happens to my existing courses where I have learners actively using the products?**

- Learners that are enrolled in a course will experience no impact and can continue using the current product.
- Until inventory is transitioned (July 24), institutions can add learners to an existing course provided inventory is available.
- When possible, new learners should be put into a new course created with the updated materials. Please first contact your NHA Representative so your inventory can be moved to the new experience prior to July 24<sup>th</sup>.

**When I create a new course, which version of the product should I select?**

Beginning June 26, only the new versions of the products will be available when you create a new course. Any unused/unassigned inventory from courses created prior to June 26 will be moved to the new products on July 24 and will be reflected in your inventory. If you require your inventory to be migrated sooner, simply contact your NHA representative for assistance.
