Building strength in health care

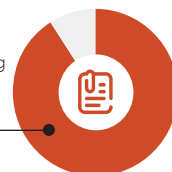

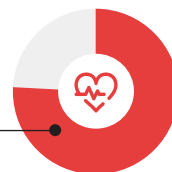

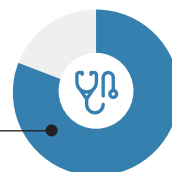

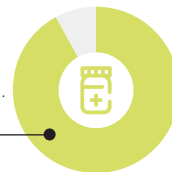

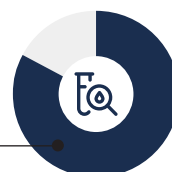

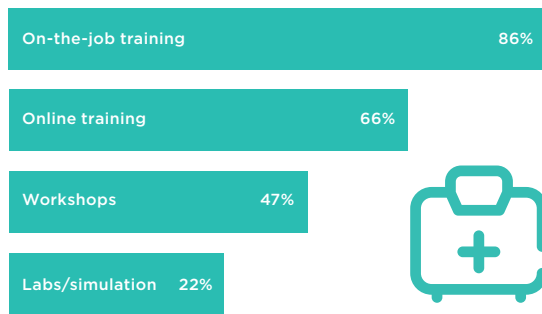

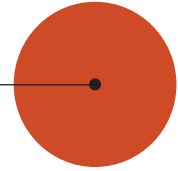

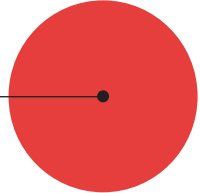
Percentage of employees that are certified within your organization. (101-178)



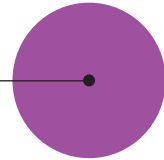

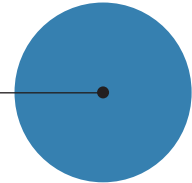

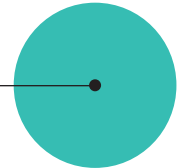

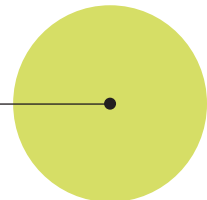

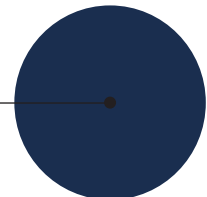

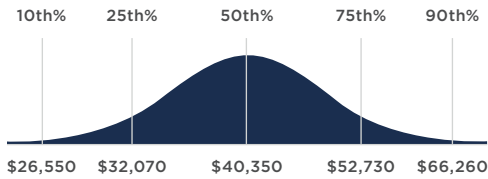

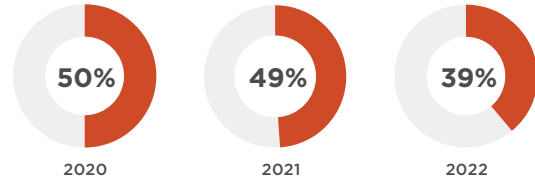

Billing & coding specialist salary range

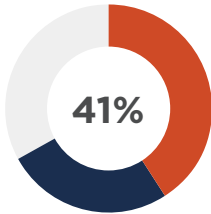

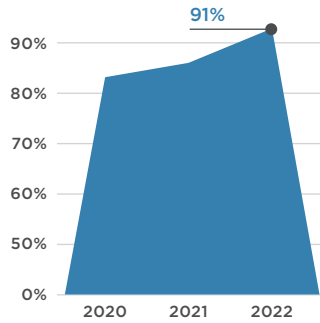

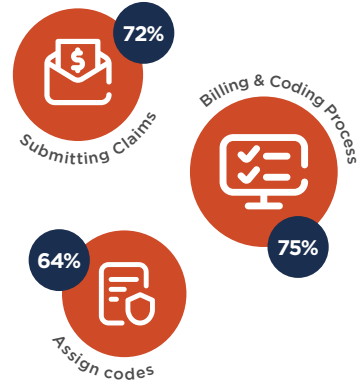

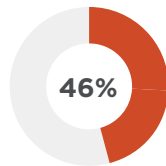

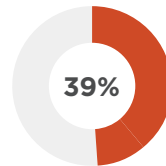

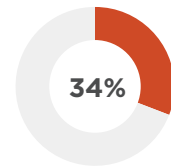

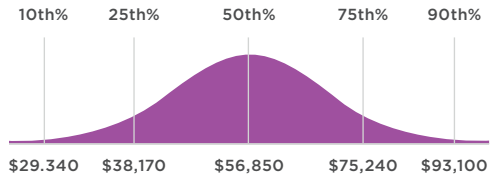

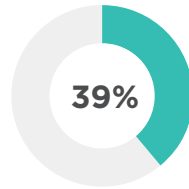

EKG technician salary range



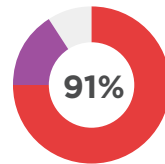

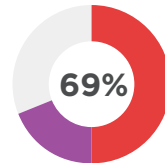

The percent of common tasks EKG technicians are responsible for has increased in the past year.

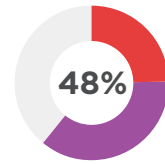

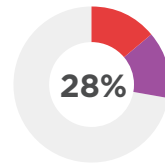

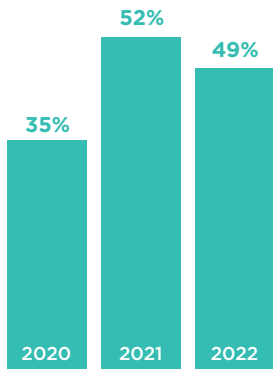

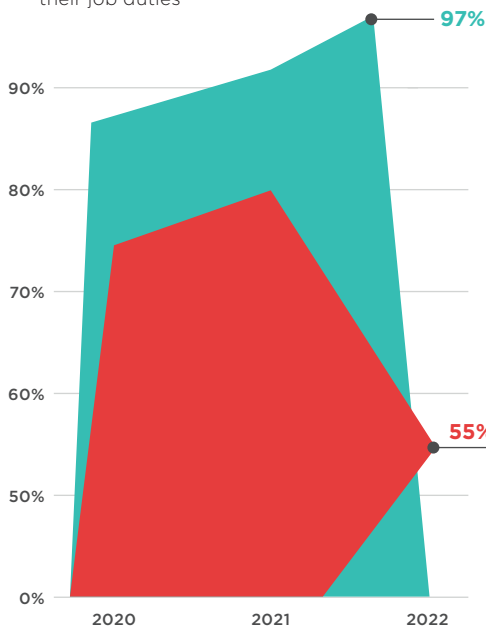

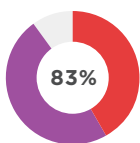
Employers rate the level of responsibility for their EKG technicians compared to last year.

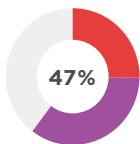

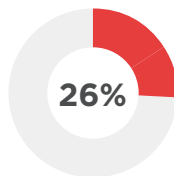

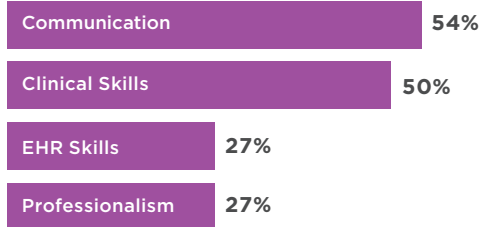

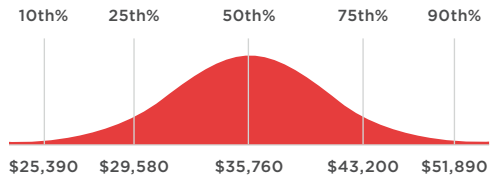


Skills newly certified EKG technicians lack (n=31)



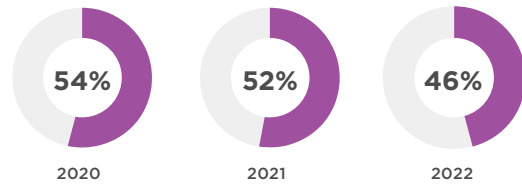

Medical administrative assistant salary range

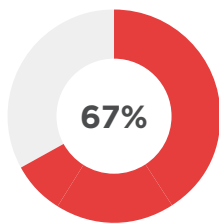

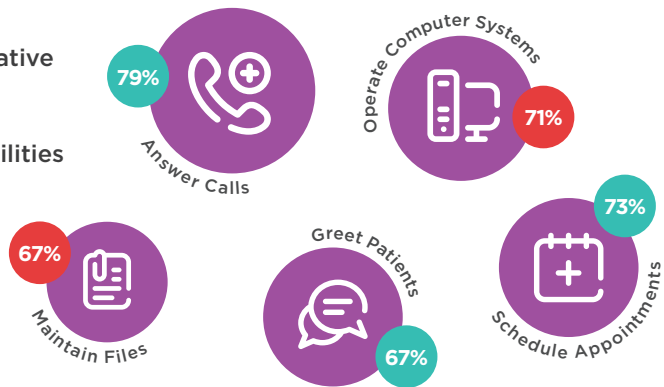

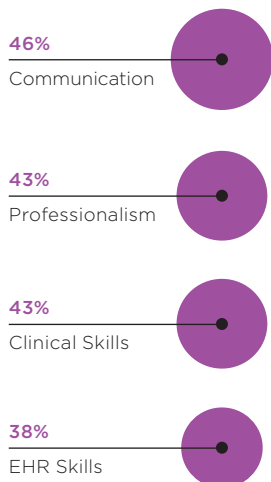

Medical administrative assistant main job responsibilities



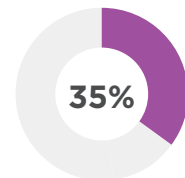

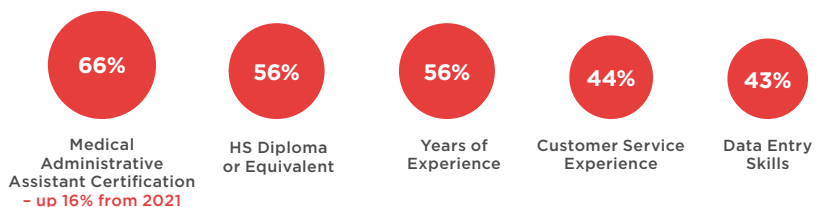

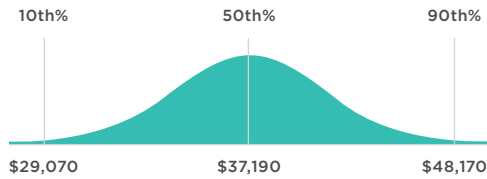

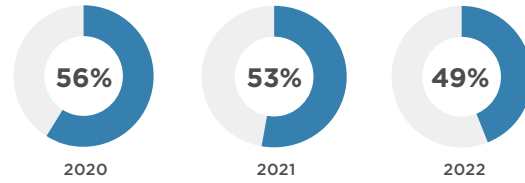

Medical assistant salary range

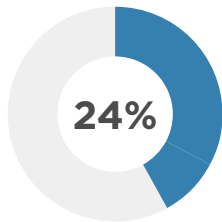

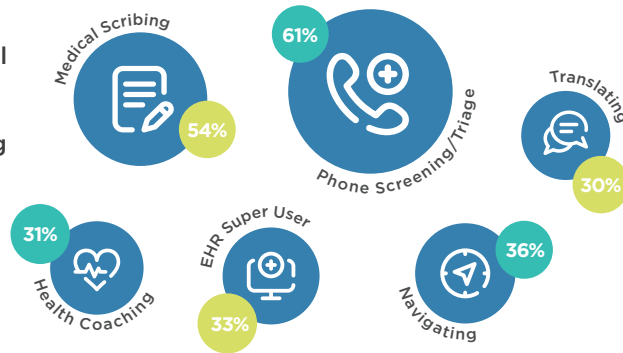

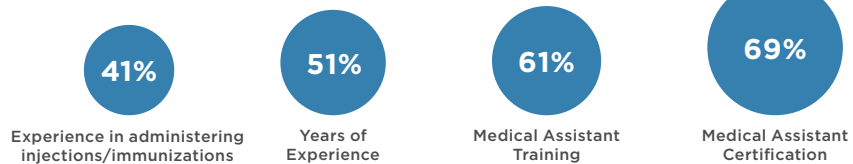

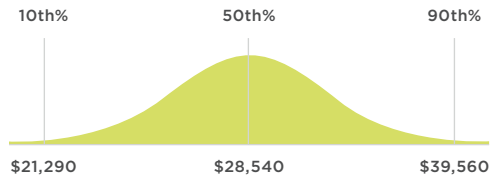

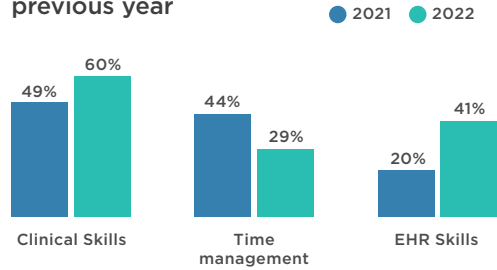

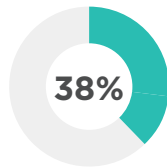

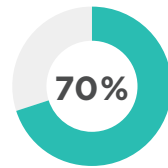

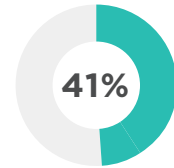

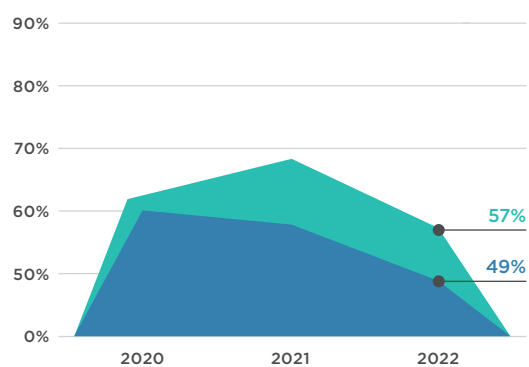

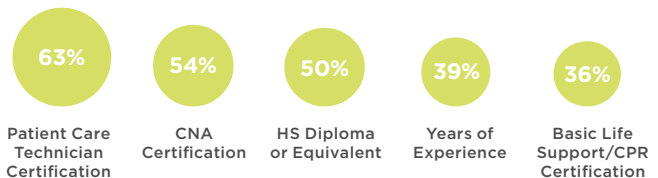

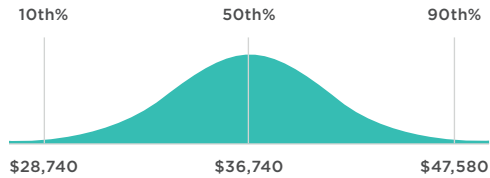

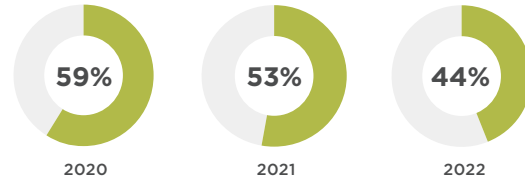
Pharmacy Technician

Pharmacy technician salary range



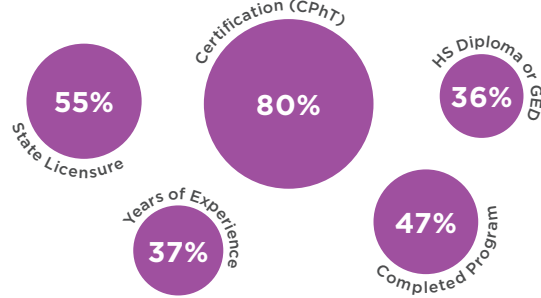

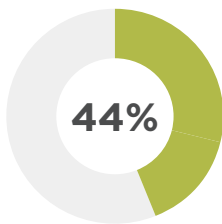

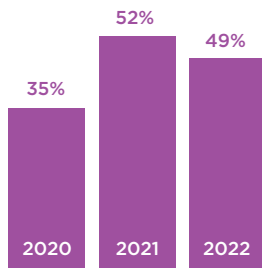

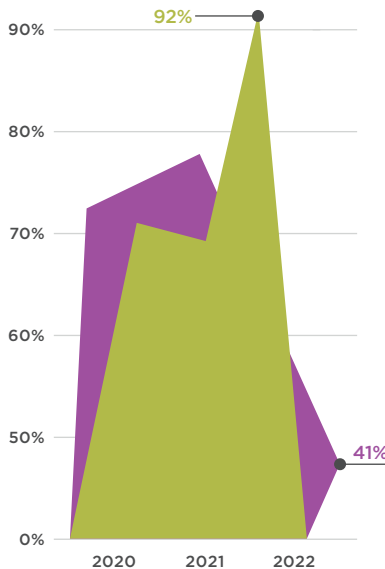

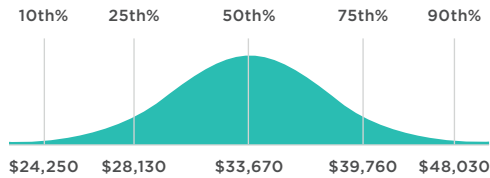

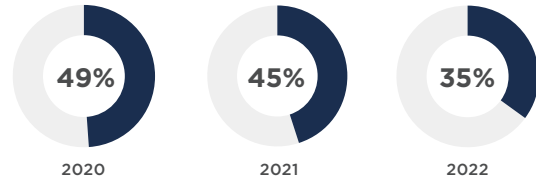
Phlebotomy Technician

Phlebotomy technician salary range

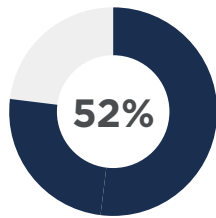

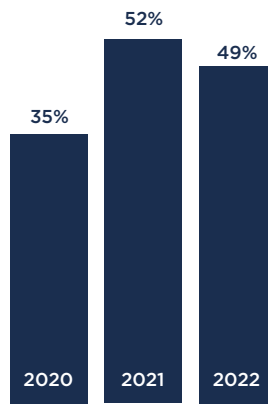

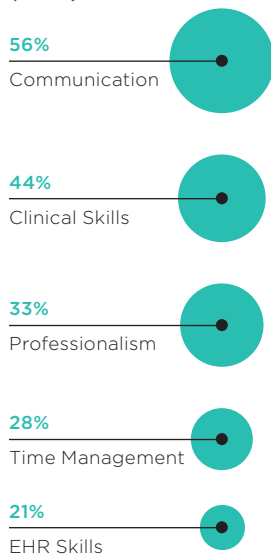

Research Methodology

A third-party research firm conducted the research for the 2023 Industry Outlook. The survey was structured to assess the opinions of employers concerning the professional outlook for billing and coding specialists, EKG technicians, medical administrative assistants, medical assistants, patient care technicians, pharmacy technicians and phlebotomists. This survey was in market May 18, 2022 through May 19, 2022 with 206 responses completed.
